AND WHEREAS the period of agreement shall be for five years and shall be subjected to revision or modification as and when required by the mutual agreement of the two Parties.

AND WHEREAS this agreement shall automatically renew after the completion of five years for another term of five years unless both the Parties agree on discontinuing it.

AND WHEREAS in the event of any disagreement in the application or interpretation of this agreement, the Parties shall endeavour to exercise their best efforts to settle their differences.
